1. RATIONAL

Government Regulation Number 19 of 2005 concerning

The National Education Standards (SNP) has provided guidance on
the importance of continuous quality improvement.

Furthermore, in 2012, through a Presidential Regulation
Republic of Indonesia Number 8 of 2012 concerning Qualification
Framework Nationally in Indonesia, the government developed a

3. DEFINITION OF TERMS

- Learning management standards are criteria minimum about planning, implementation, control, monitoring, and evaluation, as well as reporting activities learning at the study program level.
- Learning is a process of interaction between students and students lecturers and learning resources in a learning environment.
- 3. Lecturers are teaching staff at higher education institutions specifically appointed with the main task of implementing Tri Higher Education Dharma. Lecturers consist of permanent lecturers and non-permanent lecturers.
- Students are students who are registered and studying at Universitas Diponegoro.
- 5. Educational Personnel are members of society who devote themselves and are appointed to support the administration of higher education, among others, librarians, administrative staff, laboratory assistants and technicians, as well as technical staff information.

- 6. The Study Program is a unit of educational and educational activities learning that has a curriculum and methods specific learning in one type of academic education, professional education, and/or vocational education.
- 7. Department is an element of a Faculty or School supports the implementation of academic activities in one or several branches of internal science and technology type of academic education, professional education, or vocational education.
- Faculty is a collection of supporting resources, which
 organize and manage academic education and profession
 in one family of scientific disciplines and technology.
