knowledge, and skills stated in the formulation of graduate learning outcomes (Permenristekdikti No. 44 of 2015 concerning National Education Standards High, second part, chapter 5 verse 1)

- Competence is a set of intelligent actions and complete responsibility that a person has as a condition for being considered capable by the community in implementing tasks in certain areas of work
- 3. Indonesian National Qualifications Framework abbreviated as INQF is a competency qualification grading framework that can compare, equalize, and integrate education and fields of job training and work experience in order to grant recognition of work competency under Job structure in various sectors Permenristekdikti No. 44 of 2015 article 1 paragraph 5).
- 4. The Study Program is a unit of educational and educational and learning activities that has a specific curriculum and learning methods in one type of academic education, professional education, and/or vocational education
