

A. LEARNING PROCESS STANDARDS

1. RATIONAL

 The Presidential Regulation of the Republic of Indonesia Number 8 2012 concerning the Indonesian National Qualifications Framework, in 2012 developed a qualification measure Indonesian education graduates in the form of a framework qualifications, which became known as the Indonesian Qualifications Framework (KKNI). In 2015

The Minister of Research, Technology and Higher Education stipulates Permenristekdikti No. 44 of 2015 concerning National Standards of Higher Education .

2. To be in accordance with the established National qualifications accordingly, UNIVERSITAS DIPONEGORO considers it is necessary to adapt the curriculum of all existing study programs with Permenristekdikti Number 44 of 2015. Evaluation on curriculum needs to take into account inputs from stakeholders both from professional circles, graduate users or the general public. - 4. Curriculum is a set of plans and arrangements

regarding graduate learning outcomes, study materials, processes,

and assessments used as implementation of study program guideline

5. Indonesian Qualifications Framework, next abbreviated as KKNI is a competency qualification grading framework that can juxtapose, equalize, and integrating between education and fields of job training and working experience in order to grant recognition of work competency in accordance with job structure in various sectors 6. Semester Credit Units, hereinafter abbreviated as credits, are the amount of time for learning activities charged to students per week per semester in learning process through various forms of learning, or the recognition of the success of student businesses in participating in curricular activities in a Study Program
