 - b. The development of the situation and conditions of the university and/or stakeholders (*stakeholders*)
 - c. Relevance of the vision and mission of Undip
- The standard cycle is the duration or validity period of a standard in accordance with the aspects regulated therein.

5. PROCEDURE

- Study the standard control results report.
- 2. Hold a meeting to discuss the results of the report by inviting relevant structural officials and lecturers
- 3. Evaluate the content of the standard

- 4. Fill in the standard so that it becomes a new standard
- 5. Carry out the procedure as in the standard : IQAS-UNDIP/MM/01/01
