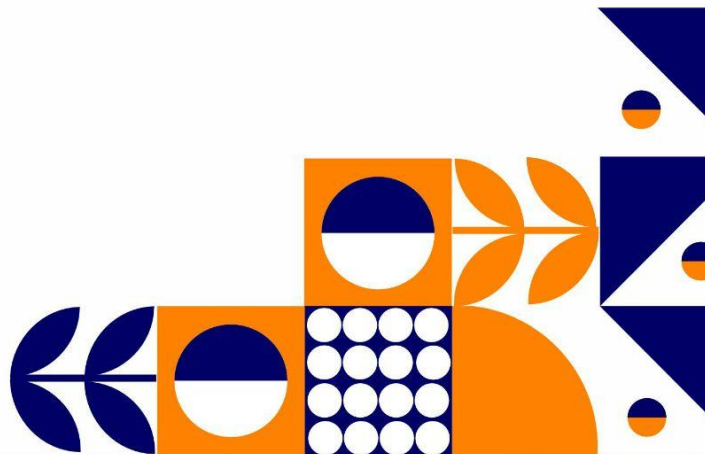

To design, formulate, and establish Internal Quality Assurance System Standards of Universitas Diponegoro

## **3. SCOPE OF THE MANUAL AND ITS USE**

This manual applies:

1. in which a standard is first designed, formulated, and determined;

2. for all Internal Quality Assurance System Standards of Universitas Diponegoro

#### **4. TERMS DEFINITIONS**

1. Designing standards is a thought process to produce standards about things needed in the Internal Quality Assurance System of Universitas Diponegoro (IQAS-Undip). This activity is in the form of elaboration and/or elaboration of 13 Undip quality standards consisting of 8 national education standards (as minimum standards) and 5 additional standards into various other standards in more detail.
2. Formulating standards is writing the contents of each standard into a complete statement using the formula A (*audience*), B (*Behavior*), C (*Competence*), and D (*Degrees*).
  - a. *Audience* is a subject who must do something; or the party implementing and achieving the contents of the standard;
  - b. *Behavior* is what must be done, measured/achieved/proved;
  - c. *Competence* is competencies/capabilities/specifications/targets/ criteria to be achieved;
  - d. *Degrees* is rate/period/frequency/time.
3. Establishing standards is an action in the form of approval and validation of standards so that standards are declared valid.
4. Tracking Study is a study to obtain the necessary data needed by internal and/or external stakeholders as reference material for determining/creating standard drafts.
5. Public Testing is a process of testing or socializing the draft standard to internal and/or external stakeholders before it is established as a standard.

#### **5. PROCEDURE**

1. Make the Vision and Missions of Universitas Diponegoro as the starting point and final goal in designing and establishing standards.

2. Collect and study all the contents of laws and regulations that are relevant to the aspect of the activity to be standardized.
3. Record the legal norms or requirements listed in the laws and regulations that must be implemented.
4. Conduct self-evaluation by applying the SWOT analysis method.
5. Carry out tracking studies on aspects that will be standardized for internal and/or external stakeholders.
6. Testing the results of the analysis of steps 2 to 4 of Undip's Vision and Missions.
7. Formulate a standard initial draft using the ABCD formula.
8. Conduct public testing or socialization of draft standards with internal and/or external stakeholders for advice.
9. Reformulate standard statements if necessary based on public test results.
10. Edit and verify standard statements to ensure there are no errors in intent (content), grammar or writing.
11. Authorize and enforce standards through establishment in the form of decrees.

## **6. QUALIFICATIONS OF OFFICIALS/OFFICERS WHO IMPLEMENT THE MANUAL**
